RESOLUTION NO. 2016-02

A RESOLUTION AUTHORIZING THE PERMITTING OF A MARTIN LUTHER KING, JR. WALK FOR THE CONCERNED CITIZENS OF HILLIARD, FLORIDA; ON STATE, COUNTY AND LOCAL STREETS, WHICH INCLUDES US HIGHWAY 1, WEST COUNTY ROAD 108, WISCONSIN STREET AND WEST THIRD STREET; RESPONSIBILITY FOR TRAFFIC CONTROL; FOR CLAIMS ARISING FROM SUCH EVENT DUE TO ACTION ON THE PART OF OR AUTHORIZED BY THE TOWN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Hilliard, Florida is required by various individuals and or organizations from time to time, to allow the use of streets and highways within the Town limits for the purpose of holding parades, or other special events, and

WHEREAS, the Town of Hilliard, determines that the Martin Luther King, Jr. Walk for the concerned citizens of Hilliard, Florida, will proceed down state, county and local roads, which may include US Highway 1, West County Road 108, Wisconsin Street and West Third Street and is an event that is acceptable, appropriate, beneficial and in the best interest of the Town, and

WHEREAS, the Town of Hilliard, is willing to assume the responsibility for this decision as it is related to acts done or authorized by the Town employees or its agents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF HILLIARD:

- That this Resolution be said and the same is hereby declared and determined to constitute the authority for the Town to request a permit from the Nassau County Sheriff's Department, Nassau County Board of County Commissioners and the Florida Department of Transportation for the approved event on state, county and local streets, which includes US Highway 1, West County Road 108, Wisconsin Street and West Third Street on the 18th day of January, 2016.
- 2. That the Nassau County Sheriff's Department will assume responsibility for traffic control.

- 3. That the Nassau County Sheriff's Department is responsible only for the claims arising from and based upon the activities of its officers, agents or employees at this event.
- 4. The Nassau County Sheriff's Office, is hereby authorized to carry out the intent and purposes of this Resolution.
- 5. That this Resolution shall take effect immediately upon its adoption.
