## ITEM-5 Legal Questions Discussion – Board Member Frey

Board Member Frey questions the legality of the ponds and/or borrow pits that had been reported to Code Enforcement because digging had begun again. The Planning & Zoning Board had previously granted permission years back to dig ponds but following the adoption of Ordinance No. 2017-14 which amended Chapter 62 Zoning & Land Development Regulations Code by adding section 62-361 Ponds and borrow pits. Whereas any expansion or change to an existing pond or borrow pit should now have to follow this section of the code.
