RESOLUTION NO. 2023-03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HILLIARD, FLORIDA, A MUNICIPAL CORPORATION AMENDING RESOLUTION NO. 2021-22, CHANGING THE SCHEDULE OF FEES FOR STREETS, SIDEWALKS AND OTHER PUBLIC PLACES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Hilliard desires to amend the schedule of fees contained in Resolution No. 2021-22.

NOW THEREFORE, be it resolved by the Town of Hilliard that:

<u>Section 1.</u> The following schedule of fees shall apply to action under the Hilliard Culverts Code. A receipt showing payment of the applicable fee shall accompany an application prior to consideration thereof:

a. Permit. An application fee for culvert installation shall be paid to the Town at the time of application for a site location inspection by the Public Works Department and a follow-up inspection to ensure that all work performed, and material used are in compliance with the requirements of Chapter 42 of the Hilliard Town Code. This fee shall not be refundable, whether or not a permit is issued.

b. Installation by the Town. If the owner requests the Town to purchase and/or install the permitted pipe with mitered ends, the fees are established as follows:

<u>Section 2.</u> Installation charge and/or culvert pipe shall be paid for (in full) at time of order and culverts shall be delivered directly to the job site. The Public Works Director shall inspect the permitted pipe.

<u>Section 3.</u> All culvert pipes installed within the Town shall be with mitered ends from the date of adoption of Resolution No. 2003-04.

Section 4. This resolution shall become effective on the date of adoption.
