ITEM-4 Recreation Department Special Audit – Richard Powell, Powell & Jones CPA

Council President Beasley asks Town Clerk Lisa Purvis to explain why an audit is necessary.

Town Clerk Lisa Purvis advises the Council of the following that needs to happen with the exiting of a department head that has cash handling rights and duties:

- ➤ A special audit of the Recreation Department in connection with the recent resignation of this department head needs to be performed.
- ➤ The special audit would cover the fiscal year ended 9/30/2020 and would be focused on the cash receipts collected, revenues billed, and related accounts receivable related to the Recreation Department.
- > A report would be prepared of the findings at the conclusion of this audit, conducted in accordance with the AICPA Agreed Upon Procedures Standards.
- ➤ The Auditors have agreed to have the work on this engagement completed by October 15th.
- > The estimated time required for this audit would be 80-100 professional hours.
- ➤ Since the Auditors can design the procedures to be compatible with the requirements of the Town's annual audit, they can discount the required fee by 40% and propose a total fee for this audit to range from \$4,500 to \$5.000.
- > The Auditors have advised that if the Town need any additional information on this proposal, they will be glad to provide and that once approved they will send an engagement letter and a request list for documents and reports required for the audit.
