ITEM-10 Nassau County Property Appraiser / Tax Collector – Homestead Exemption Audit Program Agreement

Mayor McConnell states that the Nassau County Property Appraiser's office is working on an initiative to perform an audit on the entire county tax roll in an effort to ensure that all recipients of homestead exemptions are legitimate. In order to conduct this audit, other property appraisers are using a third-party vendor to do a mass "big-data" exercise to identify potential cases of fraud. If cases of potential fraud are identified, the vendor would have the Property Appraiser's staff review each case to determine if actual fraud were present. If the Town chooses to participate in this audit, a three-party Interlocal Agreement would need to be executed between the Town of Hilliard, the Nassau County Tax Collector, and the Nassau County Property Appraiser.

Mayor McConnell further states that each taxing authority would have to agree to forego 30% of the proceeds from this effort. Twenty-eight percent (28%) of the proceeds of the lien collections costs are paid to the vendor, plus the Tax Collector's authorized reimbursement rate of 2%.
